Terms of Membership

1.0 MEMBERSHIP **1.1.** Membership will cost \$15 for a FULL Member (giving you the right to vote at the AGM), \$5 for a PENSIONER Member, and \$10 for a SOCIAL Member (no voting rights). Any person over 18 years can apply for membership via this form. **1.2.** Members will be bound by these Terms which may vary. The Myrtleford Savoy Club will attempt to notify members of changes but shall not be liable in any way for failure to do so. **1.3.** A Member must notify the Myrtleford Savoy Club of personal detail changes or loss of membership card. **1.4.** Points will not be rewarded until an individual becomes a member. Members can check points by asking a staff member. Any disputes regarding member's points is to be reported to the Manager. **1.5.** The Myrtleford Savoy Club may terminate a membership without notice including if the member **1.5.1.** Fails to comply with these membership terms **1.5.2.** Abuses any privilege accorded to the member or **1.5.3.** Supplies any misleading information or makes any misrepresentations to the Myrtleford Savoy Club Staff or Management. **1.6.** A member may terminate his or her membership at any time by giving written notice to the Myrtleford Savoy Club. **1.7.** Membership Cards are not credit cards, non transferable, can not be redeemed for cash. **1.8.** Any tax, liability, or duty arising from the members participation in the Myrtleford Savoy Club Membership Program is the responsibility of the member. **1.9.** Memberships must be approved by the clubs Committee members before being processed. This means Membership cards will not be given out until after the monthly Committee meetings.

2.0 EARNING POINTS AND REDEEMING POINTS **2.1.** Points will be credited to members account for all purchases on qualifying goods and services. **2.2.** The Myrtleford Savoy Club will determine which goods or services are qualifying and the number of points credited. **2.3.** A Member must present their membership card to staff before purchase is concluded. Failure to do so will result in no points being credited.

3.0 DEDUCTION OF POINTS **3.1.** The Myrtleford Savoy Club can deduct points from a member if points were in error, refund is given or purchase is cancelled.

4.0 GENERAL **4.1.** The Myrtleford Savoy Club can change the goods and services which qualify for points and the number of points awarded, without prior notice. **4.2.** The Myrtleford Savoy Club reserves the right to suspend or terminate the membership program at any time without notice. The Myrtleford Savoy club will not be liable for the suspension or termination of the program on any account whatsoever including any points balance in a members account at the time of the suspension or termination. **4.3.** The Myrtleford Savoy Club assumes no liability to a member whether in negligence, breach of contract or otherwise except **4.3.1.** Any claim relating to points, to crediting that number of points to the members account. **4.4.** A notice shall be deemed to be given by the Myrtleford Savoy Club to a member if it is sent to the postal or email address of the member appearing in the database. **4.5.** These terms and conditions will be constructed according to and be governed by the laws of Australia. The parties submit to the exclusive jurisdiction of the courts in and of Australia in relation to any dispute arising under these terms and conditions.
